A one-day event will be held Saturday, September 9, 2017, on the Historic Town Square in Centerville, Tennessee. This event will feature music, dance, arts & crafts, games, food, and fun! Hours are 10 a.m. until 9pm. Please fill out your application and send your registration fee as early as possible to insure a place in this event.

PLEASE READ CAREFULLY!

ALL FOOD VENDORS – All food vendors must be aware of the guidelines set forth by the Tennessee Department of Health. Any food that is prepared on site must be done in an enclosed area. Food vendors should bring a thermos of hot water for washing. All pre-made food items should be packaged individually and stored at the proper temperature. The compliance of these requirements is the responsibility of each food vendor! To satisfy the food needs of a large crowd, we ask that each vendor specify what they will be selling on the attached registration form so that we can have a variety of food and drink available to the visitors. At this time water is not available. Note: NO FOOD OR DRINK GIVEAWAYS!

Large food vendors will need to be pulled in to their assigned booths September 8th. We will be ready for vendors to set up at 8pm. If you are a large food vendor and you do not set up the night before we can not guarantee your booth Do not park on private property. We will supply electricity for overnight stays. Do not hook up to any electricity that is not supplied by the Hickman County Chamber of Commerce.

<u>ARTS & CRAFTS</u> – This category is for original art works and crafts to be displayed for sale. This event is not juried. All arts & craft vendors are asked to stay until dark.

<u>GAMES</u> – There will be a designated area featuring games and activities for the kids. No games or activities will be allowed outside this area. It is important to specify ALL games you will provide. Late registrants will be turned away to avoid duplication. <u>NO SILLY STRING, INCINDIARIES, SMOKE/STINK BOMBS, HAIR</u> OR PAINT SPRAY OF ANY KIND IS ALLOWED!

Artists and craftsmen will be arranged to the best of our ability so that all wares may be viewed and displayed in an appealing manner. Please be certain to describe your work in detail to facilitate locating your booth with others.

<u>DISPLAY AREA</u> – Upon receipt of your registration fee, you will be assigned a numbered space. Specific space requests will be accommodated based on availability at the time registration is received. Space assignments are on a first-come, first-serve basis upon receipt of registration.

Chamber volunteers will be ready to place vendors at 6:00am. Vendors must be on the Square by 8:00 a.m. for booth set-up and ready for the public at 10 a.m. Vendors are to supply their own display equipment (tables, chairs, extension cords, etc.) Booth space is approximately 10 x 12. Vendors requiring more space need to register for more than one booth. Booth space will be strictly enforced! Vendors are responsible for their own trash and put it in the dumpster provided.

Note: Vendors using trailers should include trailer hitch in length from front to back.

<u>ELECTRICITY</u> – Electricity available is 120 volt, 20 amp circuits only. For protection of your equipment, surge protection is encouraged. Extension cords must be heavy duty (14 gauge minimum) and rated for outdoor use. All extension cords and other electrical cords must be in good working order (i.e. no fraying, no cracked insulation, etc.). Electrician will inspect cords for safety. Cords that cross street and sidewalks should be covered. Electrician will be on site for assistance. Generators will be prohibited.

<u>LOCATION</u> – We are located 50 miles west of Nashville via Hwy. 100 or I-40. We are 15 miles west of the Natchez Trace Parkway via Hwy. 50.
