## **FOOD VENDOR APPLICATION**

Vintage Charms at Hideaway Farms will be held on property once owned by Johnny Cash. This will be a two day event and will feature, arts, crafts, vintage and repurposed booths. Live music will be held on Friday night starting at 7:30 and all day Saturday.

### **Vendor Information and Policies**

- Applications will be accepted through February 14th. If applications are received after February 14th a 10% late fee will be applied (depending on booth availability).
- Applications will be approved by our board directors. Vendors will be notified of the receipt of their application and approval status within 14 days of the receipt of the application.
- If electricity is needed, specific info on volts and amps must be provided on the application.
- Vendors must supply their own extension cords rated for outdoor use.
- Booth spaces are 12' x 12' each. Be sure you order the number of spaces required to include trailer tongues, doors, tables, awnings, etc. No extra space provided.
- All fees are non-refundable if event is cancelled due to weather, acts of nature, disaster, etc. beyond our control, or if vendor chooses not to set up.
- Vendors must leave booths clean at the close of the event.
- Proof of liability insurance must be included with all food vendor applications. Insurance shall be for a minimum of \$1,000,000 per incident with Vintage Charms at Hideaway Farms named as payee.
- Proof of **current** health inspection from the State of Tennessee must be provided with application.
- A list of menu items and pricing must be included with the application.

## **GUIDELINES**

### **Vintage Charms at Hideaway Farms**

Vintage Charms at Hideaway Farms is a two day event the third Friday and Saturday in April. The event venue will be available for vendor set up starting at 8am on Friday morning. Large food vendors must be pulled in and set up by 10am on Friday. All vendors must be set up and ready to sell to customers by 2pm Friday. Vendors will be allowed back in their booths starting at 7am on Saturday.

### **Please Read Carefully**

**Food Vendors:** All food vendors must abide by the guidelines set forth by the Tennessee Department of Health. Proof of liability insurance must be included with all food vendor applications. Insurance shall be for a minimum of \$1,000,000 per incident with Vintage Charms at Hideaway Farms named as payee. Proof of current health inspection from the State of Tennessee must be provided with application. A list of menu items and pricing must be included with the application. No water hook ups will be provided. The Health Department Inspector will visit each food vendor the day of the event. At each time, each vendor is responsible for paying the \$30 permit fee to the health department. If you have questions about these guidelines, please contact Megan Alford with the TN Department of Public Health at 931-729-3516 ext 112. Vendors selling home-prepared foods (jams, jellies, honey, bread, etc.) are subject to certifications by TN Department of Agriculture. **NO FOOD OR DRINK GIVEAWAYS!**

**Fees:** All fees are non-refundable if the event is cancelled due to weather, acts of nature, disaster, etc. beyond our control, or if vendor chooses not to set up. We will make every effort to remain open advertised times but reserve the right to cancel due to inclement weather or other occurrences that could endanger attendees.

**Pets:** No pets allowed except service animals. Please be sure all of your booth workers are aware of this policy.

**Equipment:** Vendors are required to furnish their own equipment (display, tents, tables, extension cords)

**Hours/Parking:** No passenger vehicles will be allowed in the festival area during festival hours. Speed limit on the property is 5 mph. Security will be provided Friday night however, the event provides no guarantee and assumes no liability for any loss or damage that might occur.

Illegal drugs and firearms are prohibited. All booth workers must be neat, clean and modestly dressed with no offensive or distasteful slogans, artwork or messages. We reserve the right to bar any clothing, exhibit or product that doesn't meet a family friendly standard.

**WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION  
AGREEMENT**

2020 Vintage Charms at Hideaway Farms

**A - Release of Liability**

In consideration of your permitting my participation as a vendor at the 2020 Vintage Charms at Hideaway Farms held in Bon Aqua, TN April 17th and 18th , 2020, I the undersigned, for myself, my heirs, legatees, executors, administrators, and all assignees, personal representatives and legal representatives, or as an officer of a corporation duly authorized to execute this agreement on behalf of the corporation, I bind the same to the terms of this agreement and do hereby waive and release any and all rights and claims for damages, death, personal injuries, or loss of property I or the corporation I am representing may sustain as a result of my participation in or presence at the event, against Vintage Charms at Hideaway Farms, etc.

**B - Assumption of Risk**

Furthermore, **I AGREE TO ASSUME ALL RISKS, WHETHER KNOWN, UNKNOWN, ANTICIPATED OR UNANTICIPATED, RESULTING FROM MY PARTICIPATION OR PRESENCE AT THE EVENT AND I AGREE TO FOREVER RELEASE THE VINTAGE CHARMS AT HIDEAWAY FARMS, IT'S EMPLOYEES, VOLUNTEERS AND SPONSORS, CONTIBUTORS, AND THEIR RESPECTIVE AGENTS, BOARDS, COMMISSIONS, AND ANY OTHER INVOLVED REPRESENTATIVES OF ALL THE AFOREMENTIONED (COLLECTIVELY, THE "RELEASEES"), WHO THROUGH NEGLIGENCE AND/OR OTHER ACTIONS OR INACTIONS MIGHT OTHERWISE BE LIABLE TO ME, INCLUDING ANY COSTS OR EXPENSES (PARTICULARLY INCLUDING BUT NOT LIMITED TO, ATTORNEY AND OTHER PROFESSIONAL FEES).**

**C - Indemnification**

**I agree to INDEMNIFY, HOLD HARMLESS AND DEFEND** the Releasees for, from and against any and all liability and responsibility whatsoever, however caused, for any and all damages, claims, or causes of action that I, my estate, heirs, administrators, executors, or assigns or corporation may have for any loss, personal injury, or death to any person, organization, whether they are a releasee of another entity, arising out of connected with, or in any manner pertaining to my participation in or presence at the Event, my use of the vendor area, or while in, on or upon the premises where the event is being conducted due to the negligence or unintentional acts of myself, my employees, my subcontractors, or independent contractors or invitees or helpers who are there because of my presence or participation. I further agree to INDEMNIFY, HOLD HARMLESS AND DEFEND , the Releasees from all liability incurred as a result of any lack of authority on my part to make this release, to assume such risk, or to sign this Agreement. I further agree if any demand is made or lawsuit indicated to which the terms of this agreement are applicable then my duty and my corporation's duty to indemnify shall begin the moment said demand is made and in that event I agree to pay for all attorney fees, expert fees and deposition and other costs as they become due.

**D - Agreement in General**

This waiver and release of liability and indemnification agreement is **INTENDED TO BE AS BROAD AND INCLUSIVE AS IS PERMITTED UNDER TENNESSEE LAW.** If any portion of this agreement is determined to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality,

or unenforceability shall not affect the validity, legality and enforceability of any other provision hereof. This agreement shall be governed by and controlled by the laws of the State of Tennessee and the venue for any legal action of any nature shall be in the courts of Hickman County TN.

I UNDERSTAND THAT BY AFFIXING MY SIGNATURE TO THIS DOCUMENT I OR THE CORPORATION FOR WHOM I AM SIGNING AM EXPRESSING MY INTENTION TO WAIVE VALUABLE LEGAL RIGHTS THAT I OR THE CORPORATION NOW POSSESS OR MIGHT POSSESS IN THE FUTURE. I AM SIGNING THIS DOCUMENT OF MY OWN FREE WILL. I INTEND THAT THIS RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT SHALL BE BINDING ON ME AND MY CORPORATION AND ON ANYONE ELSE MAKING A CLAIM ON MY BEHALF. NO ORAL REPRESENTATION, STATEMENTS, OR INDUCEMENTS, APART FROM THE FOREGOING WRITTEN AGREEMENT, HAVE BEEN MADE; I AM AT LEAST EIGHTEEN (18) YEARS OF AGE AND FULLY COMPETENT.

I EXECUTE THIS RELEASE ACKNOWLEDGING THAT PARTICIPATION IN THE EVENT IS FULL, ADEQUATE AND COMPLETE CONSIDERATION FOR GIVING UP THE ABOVE LISTED RIGHT AND BEING FULLY BOUND BY THE ABOVE OBLIGATION.
