You will need to be in the backstage area 30 minutes before the beginning of your individual pageant. These times are approximate, but we will try to stay on schedule as much as possible. There will be an area that contestants may dress and check hair/makeup. All contestants should remain backstage until their pageant begins.
- No men backstage unless you are assisting your daughter and we ask that you please inform us of your situation and accommodations will be made for you.
- Concessions will be available

Rules and Regulations:

- Queens of all pageants will be asked to be present and assist with events at the Hickman Co Christmas Tree Lighting held on November 28, 2020 on the Town Square. If the winner is unable to attend this event the 1st or 2nd Christmas Belle of the pageant will be asked to participate.
